Herbicide Fluazifop-P-butyl for control of annual and perennial grasses

Fluazifop-P-butyl 150 g/L is a systemic, post-emergence herbicide that can be used for the control of annual and perennial grasses. Trials carried out at the FAREI on the effect of fluazifop-P-butyl on these two types of grasses have shown that the herbicide is not phytotoxic to crops such as potato, onion, carrot, creepers, peanut, and banana, as well as non-gramineae ornamentals. Weeds turn yellow or red and weed control is usually completed within 3 to 5 weeks after application.

Directions for use of fluazifop-P-butyl 150 g/L EC are indicated below.

Dosage	Annual grasses: 0.83 – 1.7 L/ha (0.35 – 0.72 L/arp) depending on weed growth stage Perennial grasses: 1.7 – 5 L/ha (0.72 – 2.1 L/arp) depending on fragmentation of rhizome after land preparation	
Timing of application	The product should preferably be applied on young weeds at the 2 - 5 leaf stage and measure not more than 20 cm in height.

Weeds controlled	Annual grasses such as “Chiendent patte poule” (<i>Eleusine indica</i>), “Gros meinki” (<i>Digitaria horizontalis</i>) and “Herbe siflette” (<i>Echinochloa colona</i>) and perennial grasses like Chiendent (<i>Cynodon dactylon</i>) and “Fataque” (<i>Panicum maximum</i>) belonging to the family Poaceae (Gramineae)	
Compatibility	Not to be mixed with other herbicides
